6. Feedback from the Audit Committee

**Noted:** The Audit Committee met prior to the board meeting.

**Noted:** ER and PG briefed the Advisory Board on the following items;

- Two reports from the Internal Auditors relating to 2017 (financial controls and procurement control). safefood had performed well under both reports providing strong assurance to Members on safefood's control mechanisms.
- A representative from the internal auditor firm attended the meeting.
- The area of special focus for the 2018 internal audit is spend on research as it is good governance to have independent over sight.
- Other matters discussed were safefood's risk register and the operation of both the Protected Disclosure and the Anti-fraud and corruption policies. No disclosures had arisen under these policies during 2017.

#### 7. Presentation

**Noted:** Ray Howard and Sinead Conroy from South East Cork Area Development (SECAD) presented on the third term of the Community Food Initiative (CFI).

**Noted: safefood** appointed SECAD to administer the CFI and their role is to support the CFI leaders of each project.

**Noted:** The third term of the CFIs follows a community development approach with a social inclusion brief to reach out to the most disadvantaged on the island of Ireland.

**Noted:** Each of the CFI's is supported by a steering group, membership includes public bodies, local authorities, CFI leaders, Community organisations and Agencies e.g. citizens information.

**Noted:** A key element is to enable each CFI to develop their own steering group or network and legacy is a key word whereby the CFI can continue long after funding has stopped.

**Noted:** The Resurgam Trust and Inishowen Development Partnership facilitated Focus groups to inform **safefood**'s Start campaign. CFI leaders will now incorporate the Start campaign resources into their healthy eating programmes.

**Noted:** SECAD confirmed that these are the only CFIs operating on the island of Ireland.

**Noted:** *safefood* funds the CFIs as their contribution to the North/South food poverty network. Other bodies in the food poverty network provide other elements but none are totally focussed on food.

**Noted:** SECAD advised that they are asking each group to identify their 'standout' project so

these can be collated as best practise.

**Noted:** The Chair thanked Sinead and Ryan for their presentation.

8. Chief Executive's report

Noted: The CEO thanked all Dublin staff for the patience during the recent upheaval in the

office caused by flooding through the roof of the office. Thanks were also given to Corporate

Operations, in particular IT for their support.

Noted: In the absence of a Northern Ireland Assembly and the North South Ministerial

Council, the 2017 and 2018 Business Plans and the 2019-2020 Corporate Plan await formal

approval.

10. Presentation on General Data Protection Rules (GDPR)

GDPR which builds on existing regulation and the work undertaken by safefood to ensure

compliance. This is a European Union wide initiative which carries huge penalties for

companies and personnel not complying.

new role.
